TIDA Webinar: Defense Verdict in Florida after Motorcycle Collision with Tractor-Trailer Resulted in TBI and Quadriplegia, taking place

Raul Alvarez, Jeff Thompson, and Matt Schreck recently obtained a defense verdict in Florida for a commercial truck driver involved in a collision with a motorcycle.

As the truck driver was making a left turn across a highway, a motorcycle collided with the back of his tractor and front of his trailer. Plaintiff’s counsel argued that the truck driver should have seen the motorcycle before initiating his left-hand turn and that the motorcyclist had the right of way. Plaintiff’s counsel also argued that the tractor-trailer was blocking all lanes of travel and Plaintiff could not have avoided the collision.

Plaintiff’s counsel argued that the truck driver’s insurance policy limit was not offered fast enough, and he sought an excess verdict in order to pursue a subsequent claim for bad faith. The jury found that the operator of the tractor-trailer was not negligent and returned a defense verdict.
